The only exception is High School students that bring themselves to Co-Op (see below). This is to remain in compliance with our legal and insurance requirements.

Additional fees for High School:

- Science courses: \$12 per student, per year, per class they are attending.
- Student-only (no parent attending or participating in Co-Op): \$80 per student per year (\$40 per semester), per class they are attending.
